the number of animals killed.

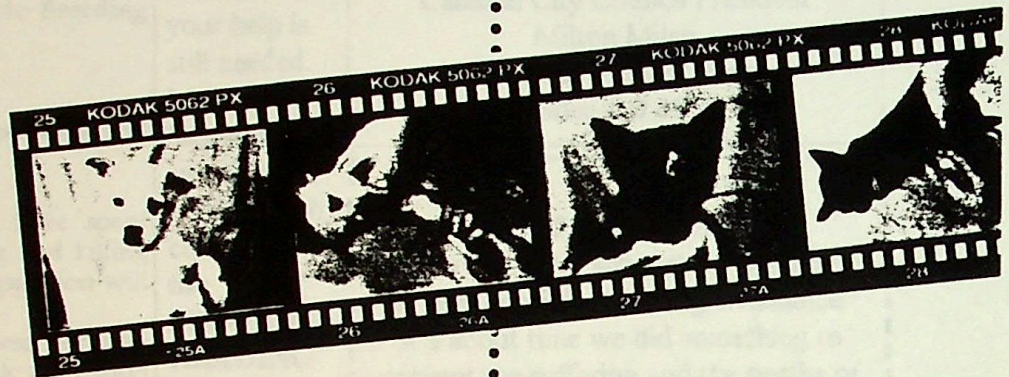

The animals aren't the only ones to pay a price. Vickie works at a shelter because she loves animals and wants to comfort them when no one else will. She ends each day by killing them.

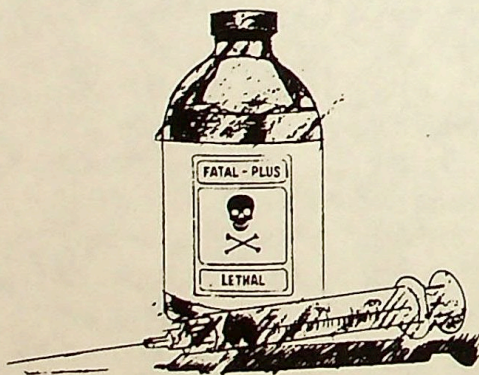
